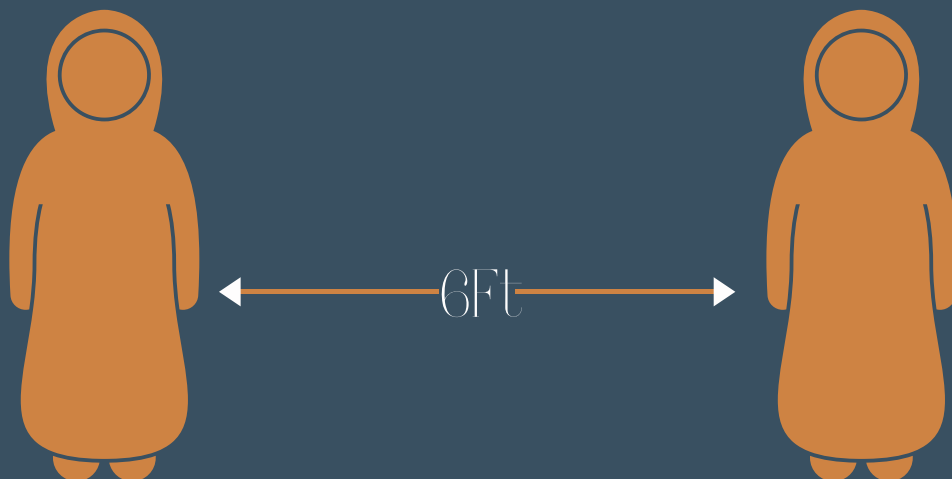

## Important Information on COVID-19 Health Care for Immigrants

### Access to Testing and Health Care

First and foremost — if you need care, go to the doctor. For your own safety and the safety of those around you, it is important that you are accessing health care if you are experiencing symptoms. Here is some important information to remember:

- There are strict laws in place that protect the confidentiality of your visit.
- Immigration law enforcement is prohibited from conducting arrests in health care facilities, such as hospitals, health clinics, and urgent care facilities except in very limited circumstances.
- You do not need health insurance to visit the doctor. Community health centers offer free and reduced cost healthcare regardless of immigration status.

### Families First Coronavirus Response Act

The Families First Coronavirus Response Act was passed in Congress and signed into law by the president.

- If you are insured through a private insurance provider, insurance providers are required to cover coronavirus tests without cost-sharing (deductibles and copays).
- If you are insured through a federal program (Medicaid, Medicare, CHIP, or the ACA marketplace), coronavirus testing will be covered. The eligibility requirements for the programs have not changed.
- If you are not insured, coronavirus testing will be covered through the National Disaster Medical System.

### Emergency Medicaid

Emergency Medicaid coverage is available for those who would otherwise qualify for Medicaid if not for their immigration status. This program would cover a medical condition manifesting itself by acute symptoms of sufficient severity (this includes severe pain) in a way that the absence of immediate medical attention could reasonably be expected to result in (A) placing the patient's health in serious jeopardy, (B) serious impairment to bodily functions, or (C) serious dysfunction of any bodily organ or part." (Social Security Act section 1903(v)(3))

## ACCESS TO OUR COMMUNITY

This program covers people regardless of their immigration status. For example, if you have temporary protected status (TPS), Deferred Action for Childhood Arrivals (DACA), are a lawful permanent resident status who has had that status for less than five years, or are undocumented, you may be ineligible for the regular Medicaid program based on your immigration status. However, as long as you meet the income and other categorical requirements for Medicaid (which vary by state), you can be covered under this program.

### Public Charge

[The Final Rule on Public Charge Ground of Inadmissibility](#), commonly referred to as the public charge rule, was put into place by USCIS on February 24th, 2020.

- If you are subject to the public charge test, getting care for COVID-19 (including vaccine in development) through Medicare, CHIP, state-only funded health programs, the federal or state marketplaces, or private insurance will NOT be counted against you.
- If your employment or education status is being affected by social distancing measures (e.g. university/school closures), you can submit a statement with your application to explain how the measures have impacted factors relating to the public charge inadmissibility determination.
- Any service received under the aforementioned Emergency Medicaid program would also not be counted against you in a public charge determination.

## EMPLOYMENT

If you are laid off work as a result of the governor's stay home order issued on March 23, you are eligible for unemployment benefits.

- When you apply for benefits, you should select "laid off" as your reason for separating from your employer. Choose "Company temporarily closed" from the secondary options.
- This does not apply to employees who are considered [essential critical infrastructure workers](#), as outlined by the governor. Before applying, download the [unemployment application checklist](#) to prepare.

### FOR SMALL BUSINESS OWNERS

- [Federal Small Business Administration \(SBA\) Economic Injury Disaster Loans \(up to \\$2 million\)](#). Congress has approved \$7 billion in funding to this program as part of its COVID-19 response. It can “provide up to \$2 million of financial assistance (actual loan amounts are based on amount of economic injury) to small businesses or private, non-profit organizations that suffer substantial economic injury as a result of the declared disaster, regardless of whether the applicant sustained physical damage.” You can apply online [here](#), though the website isn’t loading as of this writing; any questions about that or the application process can be directed to 1-800-659-2955 or [DisasterCustomerService@sba.gov](mailto:DisasterCustomerService@sba.gov).

## ACCESS TO OUR COMMUNITY

- **Seattle Office of Economic Development grants of up to \$10,000.** Drawing from a \$1.5 million addition to the city's Small Business Stabilization Fund, these grants are available to small business owners who make 80 percent or less of the area's median income; have a physical location and five or fewer employees; and have experienced a loss of income due to COVID-19. Financials must be shared as part of the process. Applications are reviewed on a rolling basis. (Update: It sounds like the mayor will add another \$1 million to the fund due to the high number of applications.)
- **Information about the city's business and occupation tax deadline extension.** The city's Department of Finance and Administrative Services extended the city's B&O filing deadline for businesses who reported \$5 million or less in revenue in 2019 and pay their B&O tax on a quarterly basis. The first and second quarters of 2020 will tentatively be due on or before October 31. The Washington State Department of Revenue (DOR) is also working with affected businesses who need tax filing extensions, and it may also waive late payments in certain situations. - **Deferred payment plans with Seattle Public Utilities (SPU), Seattle City Light (SCL), and Puget Sound Energy.** Utilities will be kept on in Seattle throughout the COVID-19 crisis. Commercial customers can set up deferred payment plans with SCL or SPU by calling 206-684-3000 or emailing here. Also, gas provider Puget Sound Energy will not be disconnecting customers, instead waiving late fees and offering payment plans.
- **Amazon's Neighborhood Small Business Relief Fund cash grants for South Lake Union and Regrade small businesses.** The e-commerce giant will draw from a \$5 million fund to support businesses with less than \$7 million in annual revenue or fewer than 50 employees with a few blocks of its Seattle headquarters.
- **Washington Small Business Development Center's Business Resiliency Toolkit and Guide.** The center will also hold webinars March 16-20.
- **The details on Mayor Jenny Durkan's moratorium on the eviction of small businesses and nonprofits.** Announced March 18, Durkan's emergency order bans evictions until the emergency ends or for 60 days. The city council still needs to weigh in.

[Information on Seattle's temporary moratorium on residential evictions.](#) On March 14, Durkan announced a 30-day ban on residential evictions related to non-payment or partial payment of rent. On March 17, the city council extended it to a 60-day ban, with the only exceptions for tenant actions that constitute "an an imminent threat to the health or safety of neighbors, the landlord, or the tenant's or landlord's household members." "Pay or vacate" notices and the initiation of eviction actions in court are also banned during that period, as are late fees.

## UTILTY ASSISTANCE

[Deferred payment plans with Seattle Public Utilities \(SPU\), Seattle City Light \(SCL\), and Puget Sound Energy.](#) Utilities will be kept on in Seattle throughout the COVID-19 crisis. Residential customers can set up deferred payment plans with SCL or SPU by calling 206-684-3000 or emailing [here](#). Check [this page](#) to see if you're eligible. Also, gas provider [Puget Sound Energy](#) will not be disconnecting customers, instead waiving late fees and offering payment plans.

**Tacoma Public Utilities:** The City Council declared a state of emergency, ordering the city's water, sanitary sewer, storm water, and solid waste utilities to postpone shutoffs for non-payment. The Council also approved the creation of an Emergency Assistance Program by [Tacoma Public Utilities](#) to allow more households to qualify for assistance. The Emergency Assistance Program is funded for up to \$1 million.



## ACCESS TO OUR COMMUNITY

**Puget Sound Energy:** No late fees or shut-offs during the coronavirus crisis. The company launched a new [energy assistance portal](#) to improve access to funds available to low income customers. The PSE Foundation, a nonprofit operating independently of PSE but helping the communities PSE serves, is donating \$250,000 to support relief efforts in the community through the Seattle Foundation as well as donating to food banks to cover emergency preparations.

**Snohomish Public Utilities:** Will not disconnect for late payments during coronavirus outbreak.

**Thurston County Public Utility District:** Customers affected by COVID-19 can request a deferred payment plan.

## PHONE, INTERNET COMPANIES

**Comcast:** (For the next 60 days) Xfinity [Wifi](#) hotspots will be free to anyone - including non-Xfinity subscribers; all customers will receive unlimited data free of charge; and no late fees or disconnects as long as a customer contacts Comcast to explain the situation.

**CenturyLink:** Waiving late fees, unlimited data and no disconnects for 60 days.

**Spectrum Mobile:** No late fees, free wifi [hotspots](#), no disconnects for 60 days.

**AT&T:** No disconnects when customers can't pay their bills because of coronavirus disruptions. The company is also waiving related late fees. Like Comcast, AT&T is also providing free access to its public WiFi hot spots. The company also said its consumer home internet wireline customers and fixed wireless internet customers would receive unlimited data.

**Verizon:** Verizon said it is [waiving late fees and](#) won't be disconnecting service for customers "negatively impacted by the global crisis."

**T-Mobile:** Unlimited data to all current customers who have plans with data for the next 60 days. It will also provide additional data to mobile hotspot users.

## FOOD ASSISTANCE

### Food Support for Seattle Public School Students

Beginning Monday, March 16, **Seattle Public Schools (SPS)** will be distributing lunches from 11 a.m. to 1 p.m. every weekday at 26 school sites throughout the city. **All SPS students can participate.** These 26 sites will become central locations for family and student resource distribution.
